- Church income has exceeded expenses by \$25,000 through the first quarter.
- WDS income has exceeded expenses by \$62,000 through the first quarter.
- The debt on the Community Center loan has been reduced by over \$50,000 this year alone.
  The remaining balance is just under \$1.8 million.

# **Trust Fund Awards a Properties Grant**

Unless you have served on the church's Properties Committee, you may never have been down to the boiler room in the basement of our education wing. However, this space houses some very important equipment that helps keep our building warm in the winter and cool in the summer, along with some large plumbing pipes. Recently, we discovered several cracks in a 5 inch cast iron pipe in this space. In addition, we found some other pipe repairs that were needed. We also reached

the end of the lifespan of our condensate tank that services our boiler. These projects all fell outside of the regular maintenance line in our Properties budget, so the committee submitted a request to the Trust Fund for \$22,000. The grant was awarded and the repairs are nearing completion.

In addition to this grant, the Trust Fund also made its quarterly \$30,000 gift to help make payments on our Community Center Ioan. These grants were made possible by over \$120,000 in investment earnings this quarter. The Trust Fund also received a gift of over \$35,000 from a Belmont family.
